- Registration **FORMS WITH PAYMENTS** must be **POSTMARKED OR RECEIVED VIA FAX OR E-MAIL**, if paying by credit card, by **JANUARY 8, 2010**, to be eligible for the Advance Rate. Forms postmarked after that date will be charged the Standard Rate.
- Payments may be made by company check, wire transfer, or American Express credit card only. Checks should be made payable to the Caribbean Cable and Telecommunications Association or CCTA. Please contact the CCTA for wire transfer instructions.
- Incomplete forms or checks with incorrect amounts will be returned to registrant, and must be resubmitted prior to January 8 to qualify for the Advance Rate.

ON-SITE REGISTRATION

- On-site registration at the Standard Rate will begin on Monday, January 25, from 12:00 to 7:00 p.m. Registration will continue from Tuesday, January 26, beginning at 7:00 a.m., through Thursday, January 28, ending at 2:00 p.m.
- All conference fees must be paid, prior to attending any event, by company check, cash or American Express credit card (we will not send billings for on-site registrations). **PERSONAL CHECKS CANNOT BE ACCEPTED.** To gain entry to any and all events, registration must be paid in full.

CANCELLATIONS AND SUBSTITUTIONS

- Cancellations must be in writing and received in the CCTA office by January 20, 2010. After deducting a \$50 cancellation fee, a refund check or American Express credit will be issued following the close of the Annual Meeting. After January 20, there will be no refunds for cancelled registrations.
- Registrant substitutions must be received by CCTA in writing by January 20, 2010, and should

be accompanied by a \$25 fee. After this date all substitutions, for which there is a \$40 fee, must be paid at the Annual Meeting Registration Desk.
